Reinstatement

- 1. Pay back all premiums
- 2. Pay interest on those back premiums
- 3. Prove insurability
- 4. Pay back loans (if there were any)

Policy may be reinstated back for 3 to 7 seven years depending on the company.

Note: A new contestable period goes into effect but there is no new suicide provision.
